**Structure of the Governing Body**

The school is a community school and it reconstituted in line with statutory guidelines on 1st April 2015.

There are 16 governors appointed:

- 5 elected parent governors

- 1 LA governor
- 1 head teacher
- 1 elected staff governor (shared 50/50 between the joint Assistant Heads)
- 7 co-opted governors (of which up to 3 could be members of staff).

The term of office of all governors (other than the head teacher) is four years.

The Governing Body has established three committees to which it delegates day to day responsibility for the oversight of various aspects of the running of the school: the Personnel & Finance Committee, the Eco & Premises Committee and the Teaching & Learning Committee.
